INDIVIDUAL BOOKING CONDITIONS

1. The **charges** agreed are based on the inflation rate at the time of printing. The Old Vicarage Centre (Hereafter known as the O.V.A.C) reserve the right to increase prices. Any increases in charges will be notified in writing to those with provisional or confirmed bookings. Confirmed bookings within three months of arrival date will not be subject to any such increases.
2. **Provisional bookings** which the Centre has accepted by telephone or in writing will be held for fourteen (14) days only from the date of acceptance.
3. A **booking** is only deemed as confirmed when the Centre has received a completed booking form accompanied by a non-returnable deposit of £75.00
4. **Final payment should be sent to the centre 4 weeks prior to your stay.**
5. **Cancellations / Reductions in numbers**
 - a) Cancellation of the entire booking made within 2 weeks of the day will be charged 25 % of the full fee.
 - b) Cancellation of the entire booking made within 1 week of the start of the stay will be charged 50 % of the original fee.
 - c) Cancellation of the entire booking made within 3 days of the day will be charged the FULL FEE .
6. All activities are subject to change and availability. No refunds can be made in respect of activities booked but not used.
7. **Liability**
 - a) The O.V.A.C are covered for Public Liability and Employers Liability. Groups requiring additional cover are advised to contact their own insurance company.
 - b) The O.V.A.C and Country Treks staff can not accept liability for damage to, or loss of, personal property. Groups are advised not to bring personal items of value with them.
8. **Smoking** Smoking is not permitted in any building.
9. **Discipline** A high standard of conduct behaviour is expected during the stay or time on site. The O.V.A.C reserves the right to dismiss guests who persistently ignore the rules or act in a manner likely to affect the safety, comfort or well-being of other guests or staff. In such circumstances no refunds will be given.
10. **Damage** Guests are responsible for the cost of any damage to Country Treks equipment and / or property caused by misuse.
11. The O.V.A.C reserves the right to cancel a booking for whatever reason. In such a situation all monies paid to the Centre will be refunded in full.
